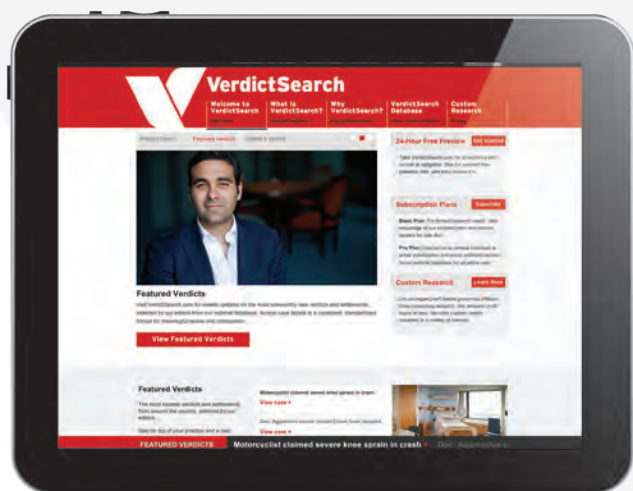

Arkansas Democrat Gazette Jury awards \$122.5 million to bomb-hurt doctor

A Crittenden County jury has awarded the former Arkansas State Medical Board chairman \$122.5 million in damages against a former Russellville doctor who orchestrated a 2009 bombing that severely injured him.

Dr. Trent Pierce was injured at his West Memphis home on Feb. 4, 2009, when a bomb hidden in a spare tire that was placed in front of his car exploded. Pierce was severely

burned and suffered broken bones and teeth, partial hearing loss and the loss of sight in one eye.

A jury Tuesday awarded Pierce and his wife, Melissa, \$17.5 million in compensatory damages for injuries suffered and \$105 million in punitive damages, attorney Robert Cearley said Wednesday. The Pierces originally filed the civil suit against Randeep Mann and other unknown defendants in 2010,

and a circuit judge issued a summary judgment in favor of the Pierces, a jury to determine the amount of damages to award the Mann was in 2010 sentenced to life in prison in the attack. Brad Edwards and Gary Farmer of Farmer, Jaffe, Weissing, Edwards, Fistos & Lehrman, P.L. in Fort Lauderdale, and Dan Cotter of The Maher Law Firm, P.A., in Winter Park, FL, obtained a \$24 million dollar verdict on June 23, 2015, in a wrongful death suit against The Riverside Hotel, in Fort Lauderdale, for the death of a guest. Alanna Demella, seven months pregnant at the time, was killed when a car traveled off of the road and into the hotel's poolside cabana she was occupying.

At trial, Edwards, Farmer and Cotter sought to prove that the hotel was negligent in failing to maintain its property in a reasonably safe condition by protecting its guest from the known danger that speeding and distracted drivers posed to guests, that the hotel knew of the growing danger, and that it could have done more to protect its guests against that danger. This was the fifth largest verdict in Florida in 2015 and the 34th highest verdict in the United States in 2015.

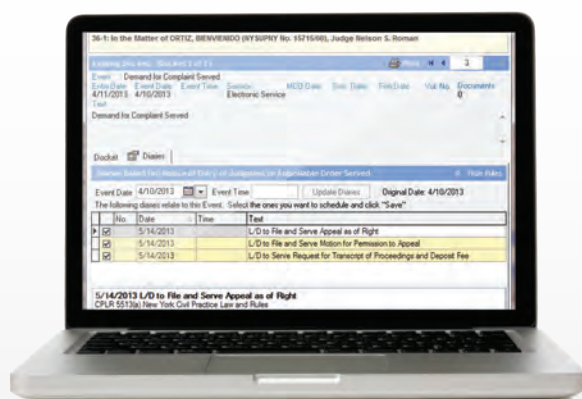

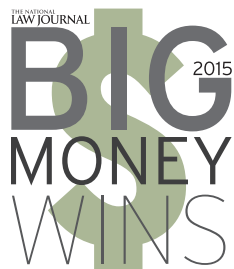

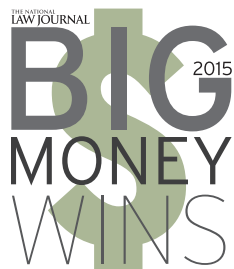
